3-2. Describe how the CoC determined that this project should be eliminated and include the date the project applicant was notified. (limit 2500 characters)

The CoC determined that this project should be eliminated by reviewing its approved reallocation process factors for involuntary reallocation along with the project's submitted FY2024 renewal application information and most recently completed APR data. The project's performance showed that only 4/12 participants in the project during the APR time period met the criteria for chronic homelessness when the project is 100% Dedicated CH. In addition, the project in its renewal application did not commit to following a Housing First approach. The number of chronic homeless individuals within the CoC increased by 74% in the 2024 Point in Time Count and the CoC had determined that increasing low barrier, Housing-First PSH beds within the CoC was a local priority in the FY2024 competition. The reallocated funds will go towards two new PH-PSH projects submitted this year. Each project commits to following a Housing First approach and will be 100% dedicated to CH. Reallocating the project to lower barrier projects that also have reduced costs will improve services and housing availability to chronically homeless individuals within the CoC and will be a more efficient use of the limited CoC resources available. This will ultimately improve overall system performance and will reduce CH numbers in future Point in Time Counts. The project was notified of this involuntary reallocation voted decision on October 10th, 2024.
